

RESIDENTIAL SIDE LOT SALE APPLICATION

The Newark Land Bank ("NLB") welcomes applications from qualified property owners to purchase the NLB vacant lot contiguous to their occupied home to plant a garden, add an addition to their home, install a driveway or garage, or simply expand the footprint of their property.

The following items must be submitted with an application for it to be considered complete:

Application and Certification Form: Must be signed and dated by all applicants. The application must be fully completed, including specific plans to improve the property, and the estimated costs associated with your plan. Likewise, the certification form must be reviewed, signed and dated.
Proof of Financing: Can include a bank statement, letter of credit, etc. Must be sufficient to cover the estimated costs to acquire <u>and</u> make the proposed improvements.
Photographs: A minimum of two current and clear photographs of the front and back of your house inclusive of the NLB lot.
\$50 non-refundable application fee.

Important Notes:

- 1. NLB reserves the right to accept or reject any application.
- 2. Failure to fill out all sections of the application or provide all requested documentation may result in denial of the application.
- 3. NLB maintains the right to place conditions on the sale and incorporate them as deed restrictions. If the buyer fails to make proposed improvements and or properly maintain the property as disclosed on their application, the NLB may exercise its discretion and take back title to the property.

Single, non-buildable lot, 1 - 2,000 square feet \$500 Single lot, 2,001-2,500 square feet \$1,000 Single lot, 2,501 or greater Negotiated
